#### Memorandum of Understanding

## Coventry Professional Fire Fighters, Local No. 3372, International Association of Fire Fighters, AFL-CIO. -and-The Central Coventry Fire District

The Memorandum of Understanding ("Agreement") is herein agreed to between the Central Coventry Professional Fire Fighters, Local No. 3372, International Association of Fire Fighters, AFL-CIO ("Local"), and the Central Coventry Fire District ("District"), with both the Local and District collectively referred to as the "parties".

WHEREAS, the parties have entered in a Collective Bargaining Agreement ("CBA") dated September 1, 2021 to August 31, 2022; and

WHEREAS, the Local has filed a grievance against the District on behalf of FF Matthew Medeiros, alleging a violation of Article 5, Section 1. Said grievance has been filed with the American Arbitration Association ("AAA") and is assigned AAA Case No. 01-21-0016-3415 and is pending arbitration; and

WHEREAS, the parties are desirous to settle the above-cited arbitration; and

NOW THEREFORE, in consideration of the mutual covenants and promises contained herein and intending to be legally and equitably bound hereby, the District and the Local agree as follows:

- 1. Providing the CCFD's third-party insurer (currently, Provident), does not cover the insurer-disputed cervical injury claims, the District shall be responsible to reimburse FF Matthew Medeiros ("FF Medeiros") for all of his out-of-pocket medical expenses associated with his cervical injuries, arising out of the September 2, 2020 work-related injury!;
- 2. The parties further agree that any medical expenses not paid by the CCFD's third-party insurance company (Provident), will first be processed through FF Medeiros's employee sponsored health insurance plan, or, in the event FF Medeiros retires or separates employment, any other health insurance plan that inures to FF Medeiros' benefit;
- 3. The CCFD further agrees that FF Medeiros shall be reimbursed for all of his out-of-pocket medical expenses as well as, any applicable deductions from his health plan deductible, within fifteen (15) days after he provides notice and receipts to the District Clerk and/or Administrator;

<sup>&</sup>lt;sup>1</sup> The intention of the parties and of this Agreement is to ensure that FF Medeiros' work-related injury, which occurred on September 2, 2020, is treated by the employer (i.e., the CCFD), and processed pursuant to R.I. Gen. Laws § 45-19-1.

- For purposes of this Agreement, "the District's third-party insurer" includes the 4. CCFD's current insurer, Provident, and any other insurer retained by the CCFD to process and/or pay work-related medical claims and expenses;
- 5. The parties agree that upon execution of this Agreement, the Local shall withdraw the above-cited arbitration case:
- 6. The parties agree that this Agreement shall not be considered a past practice of the parties or in any way precedent setting and shall not be used by the parties in any legal venue including arbitration, except for the enforcement of the terms of this Agreement: and.
- The parties agree that this Agreement shall be subject to the grievance and 7. arbitration provisions of the CBA for the enforcement of this said Agreement. FF Medeiros and/or the Union may enforce this agreement through arbitration even if Medeiros is no longer an employee of the CCFD.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed by their respective representatives who have actual authority to bind and enter into the various obligations set forth herein.
