The meeting was called to order by President Fagan-Perry at 6:32 PM. A quorum was present consisting of: President Cindy Fagan-Perry, Vice President Carl Mattson, Directors Richard Polselli, and Debra Santilli. Legal Counsel David D'Agostino, Esq., of Gorham & Gorham, Inc., Chief Brown, District Treasurer Corrigan, and District Clerk Kaplan were present. Directors Kristen Benoit and Russell McGillivray were excused. President Fagan-Perry led the Pledge of Allegiance. District Clerk Kaplan took a roll call.

A motion to approve the meeting minutes from January 20, 2022, was made by Vice President Mattson, seconded by Director Polselli, and unanimously approved.

#### New Business:

- A motion to accept the resignation of Board Member James Kuipers, with thanks and recognition for service was made by Director Polselli, seconded by Director Santilli and unanimously approved.
- 2. A motion to appoint Dorothy Berube, pursuant to Section 6 (f) of the CCFD Charter, to fill the vacated Board seat of James Kuipers until a Special Election can be called was made by Vice President Mattson, seconded by Director Santilli and unanimously approved.
- A motion for the ratification of March 7, 2022, as the date for a Special Election, pursuant to Section 6 (g) of the CCFD Charter, to fill the unexpired term of the vacated Board seat previously held by James Kuipers was made by Director Santilli, seconded by Vice President Mattson and unanimously approved.
- 4. A motion for the ratification of the Memorandum of Understanding ("MOU") between the Coventry Professional Fire Fighters, Local 3372, IAFF and the Central Coventry Fire District to resolve the Arbitration matter, AAA Case No.: 01-21-0016-3415 was made by Director Polselli, seconded by Vice President Mattson, and unanimously approved.
