# CENTRAL COVENTRY FIRE DISTRICT Special Meeting of the Board of Directors April 04, 2024 @ 6:00 P. M.

The meeting was called to order by President Pullano at 6:02 P.M. District Clerk Kaplan took a roll call for a quorum determination. Those in attendance were President Pullano, Vice President McGillivray, Director Polselli, Director Benoit, Director Santilli, Director Lavallee, Director Skurka-McAllister, Chief of Department Brown, District Treasurer Civetti, Legal Counsel Chretien, and District Clerk Kaplan. Attorney Tourgee was excused. President Pullano led the Pledge of Allegiance and gave directions for emergency exit.

President Pullano called a recess to allow all the voters to enter the auditorium. The meeting resumed at 6:17 P.M.

President Pullano reviewed the procedures for the meeting, voter qualification and voting.

Director Santilli presented a review of the District's tax bill history and a comparison of the tax rates for the fire districts in Coventry showing that the Central Coventry Fire District had the lowest rate, second largest in square miles, the most fire fighters, the most hydrants and the largest street lighting bill.

A motion to approve the proposed supplemental tax of 3.95%, was made by Vice President McGillivray, seconded by Director Lavallee, and unanimously approved.

A vote by those tax payers present was certified by members of the Coventry Board of Canvassers as complete and accurate.

The total number of votes cast was 144 with two (2) provisional ballots.

The total number of votes cast for the Proposed Supplement Tax was one hundred and six (106) with two (2) provisional ballots.

The total number of votes cast against the Proposed Supplemental Tax was thirty-eight (38).

A motion to adjourn was made by Vice President McGillivray, seconded by Director Santilli, and unanimously approved. The meeting was adjourned at 7:07 P.M.
