# CENTRAL COVENTRY FIRE DISTRICT Regular Meeting of the Board of Directors December 02 2021 @ 6:30 PM Annex Building 1675 Flat River Road, Coventry, RI 02816

The meeting was called to order by President Fagan-Perry at 6:30 PM. A quorum was present consisting of: President Cindy Fagan-Perry, Vice President Carl Mattson, Directors Richard Polselli, James Kuipers, Russell McGillivray, Kristen Benoit, and Debra Santilli. Legal Counsel David D'Agostino, Esq., of Gorham & Gorham, Inc., Chief Brown, Frank Napoli and District Clerk Kaplan were present. District Treasurer Jeffrey Wadovick was excused. President Fagan-Perry led the Pledge of Allegiance and gave safety instructions. District Clerk Kaplan took a roll call.

A motion to table the meeting minutes from November 18, 2021, was made by Vice President Mattson, seconded by Director Kuipers, and approved.

#### New Business:

A motion to move Item 5 from the Agenda to Item 1 was made by Vice President Mattson, seconded by Director Santilli, and unanimously approved.

A motion to approve the Adoption of Resolution #2021-22 to change Bank Account signatories, in anticipation of District Treasurer transition, was made by Director Polselli, seconded by Vice President Mattson, and approved. Director Benoit asked if she was considered to be a signatory, but since she is the Finance Director for the Town of West Warwick, President Fagan-Perry thought it might be too much to impose upon her. Director Benoit voted opposed to the resolution.

An update from the District Treasurer was presented by Frank Napoli. He presented several scenarios to the Board.

A discussion of resignation of District Treasurer and a transition/succession plan, and an update on potential options by Legal Counsel was held.

Chief Brown reported on the status of COVID-19 funding from the Town of Coventry. Directors Benoit and Kuipers will present a proposal to the council for consideration. The Coventry Town Council meeting scheduled for December 20<sup>th</sup> will not allow comments. The January 10,2022 Town Council meeting will allow comments.

Chief Brown reported on SAFER (Staffing For Adequate Fire and Emergency Response) Grants.

An update from Legal Counsel D'Agostino on potential change of Injured-On-Duty claims administrator and insurer was presented to the Board. The existing insurer is in line with the bid from VFIS. If VFIS will bid on General Liability policies the Board may consider a change, with an updated timeline of January 01,2022.

A discussion of options for lobbying the General Assembly for relief from State mandates for flexibility for financially troubled municipal/quasi-municipal entities was held. It was decided that State Senators and Representatives from the Town of Coventry should be invited to the next Special Meeting on December 9, 2021.

#### **Public Comments:**

Lieutenant McCann brought up the termination of a firefighter.

Director Kuipers requested that the Board schedule an Executive Session at its December 9, 2021 special meeting to address pending arbitration matters involving the IAFF Local 3372.

A motion to adjourn was made by Vice President Mattson, seconded by Director Santilli and unanimously approved. The meeting was adjourned at 7:15PM

### RESOLUTION TO APPOINT MRP, INC. AS DISTRICT TREASURER

WHEREAS, the Board of Directors ("Board") serves as the governing body of the Central Coventry Fire District ("CCFD"), which is a quasi-municipal/quasi-governmental entity and body politic created by an Act of the General Assembly;

WHEREAS, the Board is empowered by the Charter of the CCFD, specifically, Section 6 (a) (6), Section 6 (b), and Section 9, to appoint a Treasurer;

WHEREAS, the Board has determined that it is in the best interest of the District, and is consistent with the Board's business judgment to appoint a Treasurer for the purposes enumerated in Section 9, and such other duties and responsibilities as the Board deems necessary and appropriate from time to time; and,

WHEREAS, the Board has provided for an administrative expense in the Fiscal Year 2021-2022 District Budget an amount of Fifty Thousand Dollars (\$50,000.00) sufficient to provide said Treasurer services,

**NOW THEREFORE**, in consideration of the foregoing, the Board of Directors of the Central Coventry Fire District, at a Special meeting duly called on the 23<sup>rd</sup> day of December 2021, hereby appoints MRP, Inc., a Rhode Island business corporation, as District Treasurer of said District for an amount not to exceed \$50,000.00 for the Fiscal Year 2021-2022.
